### **COVID-19 SAFETY ACKNOWLEDGEMENT**

LIABILITY WAIVER AND RELEASE OF CLAIMS COVID-19 SAFETY INFORMATION: While participating in events and classes held or sponsored by Kailua Crystals “social distancing” must be practiced between all persons (except those in the same household) and face coverings worn at all times to reduce the risks of exposure to COVID-19. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.
